

- 2. 18 (current + backlog) vacancies in ST category remained unfilled as no ST candidate appeared in the examination. Further, 3 UR PH and 1 SC PH vacancies remained unfilled due to non availability of suitable PH candidates and these vacancies shall be carried forward to subsequent recruitment years. Furthermore, result in respect of candidate has been placed in sealed cover due to provisional candidature.
- 3. The names of the candidates have been arranged in the order of merit. If however, there is any mistake in the Name/Roll Number/Community of the candidate is noticed the same may be corrected and intimated to this office immediately. The candidates who obtained same marks, Divisional Heads are requested to decide their seniority at their end as per rule.
- 4. Before issuance of appointment orders to the selected candidates, all Divisional Heads should match the photograph of the candidate allowed to appear in the examination with the videography recorded during the examination. CD/DVD of Paper-I, II & III containing videography of said examination will be supplied to all the Divisional Heads by SSPOs Ambala.
- 5. The Divisional Heads before promotion of the official should ensure that no vigilance/disciplinary case is either pending or contemplated against him/her and no punishment like stoppage of increment is current against the official. In case there is any such case, the official concerned may not be promoted and the facts be reported to this office immediately.
- 6. The eligibility of the candidates to take the examination has been decided on the basis of the information furnished by the Divisional Heads while forwarding their applications for this examination. Therefore, all the Divisional Heads are requested to check up the eligibility of the candidates before going ahead. If it is later on found that any of the selected candidate was not eligible to take the examination under the existing rules or instructions on the subject or for any other reason whatsoever, his/her name will be deleted from the list of successful candidates or list of candidates securing concession as the case may be. The result is also subject to change due to retotaling and verification of answer books in accordance with the instructions in this regard.
- 7. All the Divisional Heads are directed to finalize the candidature of candidates who were allowed to appear in said examination on **PROVISIONAL BASIS** and furnish the report to this office by <u>19.02.2025</u>.

8. In case, any candidate is not willing for promotion to the cadre of Postman/Mail Guard, then his unwillingness duly signed by him/her, verified and countersigned by the Divisional Head should be submitted to this office by 19.02.2025. If no unwillingness is received from any candidate within stipulated time, he/she will be deemed relieved.
